
#### **Mobile Apps**

Provides access to the standard graphs that are available. Custom graphs can be developed if required.





#### **Guidance and Links**


Provides access to manuals, useful information and links to external web sites.

#### **People & CTW Management**

- Personnel Information Manage your personnel information including emergency contacts and documents (resumes, job descriptions) for your employees and contractors
- Training Records Manage all your personnel (employees and contractors) and their specific qualifications, licences, training, inductions, medicals, certificates, blue cards etc. including expiry dates and documentary evidence
- Access your Master Register of qualifications, training, courses, inductions, medicals or assessments that are required by your workers (Competencies to Work – CTWs)
- Reports view Compliance Reports for your personnel
- Includes Summary Dashboard Reporting
- Get Automatic Notifications of upcoming competency to work expiries

Role Profiles – Establish your Compliance Rules for the roles your personnel undertake and check that their CTWs meet the role profiles










# **CONTRACTORS**




# **HAZARD REGISTERS**

Record hazards identified in the work place. Attach documents and photos to your Hazard notification. Ensure hazard reports are closed out.



#### **Incident Reporting**

- Reporting rsured™ provides a simple business process for reporting, investigating and analysis of Incidents. Track the status of and accountability for Incidents and any actions resulting from the Incident.
- Classification Classify your incidents in accordance with the regulators requirements to determine if the regulator is required to be notified.
- Statistics Automatic generation of Key Performance Indicator information. Summary dashboard reporting of Incidents and Investigations.

#### **Incident Investigations**

Business process for investigating incidents – Record contributing factors and incident costs. Attach any regulator documents to the incident.

#### **Incident People**

Manage and record information about personnel involved in the Incident.

#### **Return to Work**

- Manage the rehabilitation process for your workers.
- Manage all the tasks required in the return to work plan and receive automatic reminders when the tasks are due.
- Record all your medical certificates and receive automatic reminders when they are due for review.







#### **Inspections and Observations**


- Forward schedule your inspections and allocate to responsible people. Record observations made during your walk around. Attach documents and photos to your Inspection or Observation.

- Log all your Safety Bulletins and provide access to all personnel.






